Frequently asked questions

1. Battery life health – is it necessary to completely drain the battery before you recharge it?

You do NOT need to completely drain the battery before recharging. We recommend leaving the unit plugged in and charging when not in use.

2. Is it possible to pair multiple receivers with one transmitter? How is it paired, and how will additional receivers be charged?

Yes, additional receivers are available to purchase with the products listed (please see Sennheiser Product & Price Catalogue for part numbers and prices of compatible receivers).

The transmitter cannot charge more than one receiver at a time; therefore, additional receivers must be swapped to charge each one separately. For some models, a charging accessory can be used instead of the transmitter for charging.

Pairing the receiver is typically done by placing the additional receiver on the transmitter. See the Product Comparison chart for more details on how many additional receivers can pair to a particular product.

3. What can reduce the wireless range or cause interference?

Wireless range is measured line of sight with no obstacles in the way (i.e., clear air space). When you put an obstacle (i.e., wall) between the transmitter and receiver, the wireless range is affected. The density of an obstacle will determine to what degree the wireless range is affected.

4. If someone else in the house is using Phonak hearing aids with a TV Connector, can a Sennheiser system also be used?

Yes, in theory both a Phonak system and a Sennheiser system should be able to be used in the same house. Functionality of the systems will depend on where

the transmitters are placed, the wireless signal environment, etc. In general if two (2) transmitters are being used, it is recommended having at least one meter (3 feet) between the transmitters to help prevent interference.

5. Do Sennheiser TV listening products support Dolby?

Sennheiser stethosets (i.e., Set 880, 860, Flex 2000, etc.) that are connected with an optical cable support PCM only. If the TV or other source is providing a Dolby or other sound format, the transmitter cannot convert the signal. Please ensure that the TVs digital audio output format is set to PCM. Sennheiser wireless headsets (TVS 200 and ConC 400) support Dolby when used with Sennheiser TV Clear Transmitter 2 or Sonova TV Connector.

6. Can any of the Sennheiser products work with telecoils in hearing aids (through induction loops)?

The Flex 5000 has a headphone jack that will support an induction loop such as the EZT 3012, which will allow audio transmission to telecoil-enabled hearing aids.

7. What are the hearing profiles and how does the user choose the right one?

The hearing profiles provide more or less low and high frequency gain to the audio output. Depending on the product, there may be 3, 5, or 7 profiles to choose from. Which profile is correct for a given user is dependent on personal preference, and the user should experiment until they find their preferred setting. More details on the hearing profiles can be found within the Instruction Manual for the relevant product.

8. Where can I find more information about common troubleshooting problems and solutions?

Please refer to the Instruction Manual of the relevant product for a troubleshooting guide and additional product details.

9. Do the TVS 200 and Sonova hearing instruments use the same TV transmitter?

No – the TVS 200 uses the TV Clear Transmitter 2, which is not compatible with Sonova hearing instruments.

10. Do the ConC 400 and Sonova hearing instruments use the same TV transmitter?

Yes, both the ConC 400 and Sonova hearing instruments use the same Sonova TV Connector, with AirStream technology. The TV Connector can pair to both types of devices simultaneously, allowing multiple users with Sennheiser ConC devices and Sonova hearing instruments to easily watch and listen to TV together.

*Sonova TV Connector is an additional optional accessory for ConC400 and not included with the earbuds.

11. Can the TVS 200 earbuds be purchased separately from the TV Transmitter (i.e., for other listeners in the household)?

Yes, the TVS 200 earbuds are available as a standalone purchase, and multiple sets of earbuds can be paired to one TV Transmitter.

Terms and Conditions of Sale

These Terms and Conditions of Sale (the “Terms”) govern all product transactions between the business organisation (“you”) and Sonova Australia Pty Ltd (“We” or “us”) in relation to consumer hearable products (Sennheiser branded). Price

The List Price of the Products will be published by us from time to time and will have effect 30 days from the date of our notification to you. We reserve the right to vary our List Price at our absolute discretion, subject to the provision of 30 days prior notice.

All consumer hearable devices is subject to GST in Australia.

A Tax Invoice will be emailed to the designated account email address.

Orders

Product order forms can be requested via the above email address or by visiting the Phonak or Unitron Australia website. Sonova Wholesale takes all reasonable endeavours to meet your requested time frame for the delivery of orders once the order form is processed. The delivery time may be impacted if you do not complete the mandatory fields on the order form, including but not limited to the ‘Required By’ section. Sonova Wholesale will endeavour to deliver your orders to you by the times stipulated below. Note, these times exclude transit time.

Orders not accompanied by a current order form may experience delays in processing.

The Order shall be considered as being formally accepted by us when it has been successfully communicated to Sonova using an accurately completed Order Form without any account blocking for the customer’s account with us.

Warranty

International 2-Year Warranty

Sennheiser products purchased from us come with an international 2-year manufacturers’ warranty, covering manufacturing and material defects, commencing on the date of the original Tax Invoice. This warranty does not cover damage caused by improper handling, wax or moisture damage. Repairs made by unauthorised parties are not covered and will void the warranty.

Loss and damage

Please note that we do not provide any coverage for loss or damage for Sennheiser products.

Return for credit

Only exchanges will be granted for returns of faulty or damaged products.

Under no circumstances are returns for service and repair to be sent to Sonova Wholesale.

To qualify for an exchange, all products must be returned in their original unopened, undamaged Sennheiser packaging and must be accompanied by a completed Credit Return Request Form.

Payment terms

Our credit terms are strictly thirty (30) days from the date of the statement of accounts (“Statements”). Acceptable forms of payment include Direct Deposit (preferred), Visa and MasterCard.

Delivery

Products will be delivered to you by courier at the expense of us. Bulk orders may take longer to arrive and, at our discretion, may incur a delivery charge which will be at your expense

An authorised signatory of you must sign on the delivery receipt provided by the courier service provider entrusted by us (“Delivery Receipt”) to confirm the Products’ delivery within the same day upon the delivery to your registered business address. Your signature on the Delivery Receipt shall be deemed as your formal confirmation on the conformity of the Products delivered by us with the corresponding Order Form (including but not limited to model and quantity therein) and completion of delivery of the Products under the corresponding Order Form (hereinafter the “Completion of Delivery”), unless there is any mandatory provisions to the contrary under applicable laws and regulations. The Completion of Delivery shall nevertheless take place upon the expiry of three (3) days from the date of delivery as shown on the courier service provider’s or our internal record, in the event that you fail to sign on the Delivery Receipt within such period of time

To the greatest extent permitted by applicable laws, we shall have the right to suspend, partially or wholly, on a temporary or permanent basis, the delivery of any Products without bearing any liabilities under any of the following circumstances:

- (a) if any amounts due and payable by you remain overdue for payment after thirty (30) days from the date of the Statements;
- (b) there is any suspension of the manufacturing, upgrading, change in the packaging or a difficulty in delivering of such Products on time for reason whatsoever (provided that we shall inform you as soon as practicable);
- (c) we exercise our right to terminate the Terms in accordance the Terms or applicable laws; or
- (d) you fail to observe any other terms of any contract with us;

- (e) you reach arrangement with creditors, become bankrupt, or any administrative or judicial proceeding is initiated for your bankruptcy, or you have a receiver appointed to all or any part of your assets or business;
- (f) a resolution is passed for your business' winding up;
- (g) you fail to satisfy any judgment against you within fourteen (14) days of the date of the judgment; or
- (h) we, in our opinion, consider you being unable to pay your debts.

Force majeure. A party will not be liable for any failure to perform, or delay in performing, an obligation under this agreement if the failure or delay arose from a cause beyond its reasonable control. That party must give the other party notice of the cause as soon as possible after becoming aware of it and must take all reasonable steps to mitigate the consequences of the failure or the duration of the delay.

For the purposes of this clause, a 'cause beyond the reasonable control of a party' includes an act of God, war, terrorism, act of public enemy, blockade, revolution, riot, insurrection, civil commotion, lightning, storm, flood, fire, earthquake, explosion, embargo, strike, trade dispute, pandemic or industrial action.

All orders, including accessories, under \$50 will incur a \$10.50 (plus GST) shipping fee.

Bulk orders may take longer to arrive and, at our discretion, may incur a delivery charge which will be at your expense.

An authorised signatory must sign for the products upon delivery. The products will only be delivered to your registered business address.

Termination

We reserve the right to suspend or deny, in our sole discretion, your access to all or any portion of the Account, and you agree that (i) any termination of your access to the Account may be effected with or without prior notice, and (ii) we may immediately deactivate or delete your Account and all related Account information, files in your Account and restrict or prohibit any further access to the Account; (iii) we shall not be liable to you or any third-party for any termination of your access to the Account.

If you no longer wish to be our customer, a written notification to us ninety (90) days in advance is required.

You acknowledge and agree that we are the sole and exclusive owner of all intellectual property rights related to any and all Products and other works, developed, made, written, created, discovered or designed by us, our employees or agents. On termination our brand-related marketing and promotional material must be removed from publication immediately, or destroyed upon our request.

Limitation of liability

Notwithstanding anything to the contrary hereunder, our liability in relation to warranties and conditions hereunder is limited to the extent of our mandatory obligations under the applicable laws.

To the greatest extent permitted by law, our liability for consequential loss or damage caused by or arising out of the use of the Products, loss or damage due to wear and tear, negligence, improper use, storage or handling, or loss, injury or damage arising from fire, accidents, industrial disputes, civil disturbances or any other act of accidental default as and from the date of delivery of the Products is hereby excluded.

We shall not be responsible to third parties for any claim arising out of your activities and our liability for any monetary amount as a result of such a claim is hereby excluded.

Applicable laws and Jurisdiction

The Terms are governed by the laws of New South Wales. You irrevocably and unconditionally submit to the exclusive jurisdiction of the courts of New South Wales.

If any provision of the Terms is found to be invalid or unenforceable by a court of law, such invalidity or unenforceability will not affect the remainder of the Terms which will continue in full force and effect.

In performing its obligations under the Terms, each Party will comply with all applicable laws and regulations, including but not limited to antibribery and anticorruption laws, as well export control and trade regulations, and the Annex B of the Terms.
